

ORDINANCE #202

AN ORDINANCE TO AMEND THE STOCKBRIDGE TOWNSHIP
OPEN HOUSE PARTY REGULATION ORDINANCE, ORDINANCE
NO 202 AND TO ESTABLISH AND PROVIDE FOR CIVIL
INFRACTION FINES FOR VIOLATION OF THE ORDINANCE
IN ADDITION TO OTHER REMEDIES.

THE TOWNSHIP OF STOCKBRIDGE ORDAINS:

SECTION 1: The Stockbridge Township Open House Regulation Ordinance
is amended by the addition thereto of the following:

SECTION 73-7

SANCTIONS FOR VIOLATION

Any person or other entity who violates the following provisions of
this Ordinance is responsible for a municipal civil infraction as
defined by Michigan law and subject to a civil fine determined in
accordance with the following schedule:

A. For violation of any provision of this Ordinance:

1st violation within 3-year period*	\$ 500.00
2nd violation within 3-year period*	\$1, 000.00
3rd violation or subsequent violation within 3-year period*	\$2,000.00

*determined on the basis of the date of violation(s).

B. And the violator shall pay costs, which shall include all direct or indirect expenses to which the Township has been put in connection with the violation. A Violator of this Ordinance shall also be subject to such additional sanctions remedies, and judicial orders as are authorized under Michigan law. Each day a violation of this Ordinance continues to exist constitutes a separate violation.

Section 2. The remaining provisions of Ordinance NO 202 and all amendments thereto are hereby ratified and reaffirmed.

Section 3. In the event that any provision of the within amending Ordinance for any reason is held to be unconstitutional or void, that provision shall be struck from the amendment and severed, and the remaining provisions shall be enforced according to their terms.

Section 4. The within amending Ordinance shall be effective 20 days after adoption and publication as provided by law
