Maintain and supply direct phone numbers and security access codes to S.A.E.S.A. (Stockbridge Area Emergency Services Authority) and local law enforcement.

Annual renewal and inspection of special use permit compliance required.

If at any time, there is a violation of the agreed upon special use permit, site plans, or operating conditions, Stockbridge Township Board may revoke the Special Use Permit.
